CODE OF CONDUCT**

(All groups are part of the USY organization)

As a USYer or guest attending a synagogue sponsored event, I promise that I will uphold the standards of USY. I will respect others and myself. I understand that if I fail to abide by the standards set forth below that disciplinary action may be instituted. Accordingly, I acknowledge that I have reviewed and agree to the following rules of conduct:

1. Under no circumstances will I violate any civil or criminal law including, but not limited to, those relating to tampering of or destruction of one's own or another person's physical and/or mental integrity.
2. Under no circumstances will I possess or use tobacco of any kind, illegal non-prescription drugs, or alcohol at any function. Under no circumstances will I possess or use any type of weapon or firearm at any event.
3. I will not engage in any action that may be perceived by reasonable persons to be sexually harassing in nature.
4. I will refrain from engaging in inappropriate physical contact. I will not enter a room designated or assigned for exclusive use by members of the opposite sex.
5. I will use only approved USY transportation during any USY event. I understand that no USYer may rider in a car driven by a (USY or non-USY) high school student during any event.
6. I will observe religious policies established by the USCJ.
7. I will attend and participate in the event in its entirety unless excused in advance by the youth director.
